## INTRODUCTION AND SUMMARY

The Ontario Energy Board (OEB) has, on its own motion, pursuant to section 41 of the OEB's *Rules of Practice and Procedure*, decided to review and vary its Decision and Rate Order in this proceeding issued on April 16, 2020 (Decision).

The Decision approved the incentive rate-setting mechanism application filed by Orillia Power Distribution Corporation (Orillia Power) for new rates effective May 1, 2020. In light of the uncertainty regarding the severity and duration of the COVID-19 emergency, the Decision also granted Orillia Power the option to postpone implementation of its new rates until November 1, 2020.

On April 23, 2020, Orillia Power filed a letter with the OEB, advising that the utility intends to postpone the implementation of its new rates until November 1, 2020, with the exception of the rate rider relating to Shared Tax Savings. Orillia Power stated that it is seeking permission to implement the Rate Rider for Application of Tax Change (2020) - effective until April 30, 2021 on May 1, 2020. This credit will benefit all customers and coincide with the expiry of the previous rate rider for Shared Tax Savings. Orillia Power stated that the only remaining rates subject to change are the Network Service and the Line and Transformation Retail Transmission Rates which have increased significantly. Deferring the noted rate increases is the reason for the request for a deferral of implementation until November 1, 2020 in order to further assist customers affected by the COVID-19 emergency.

## THE PROCESS

The OEB has decided, pursuant to sections 6(4) and 21(4) of the *Ontario Energy Board Act, 1998*, to review and vary the Decision and Rate Order without a hearing as no person will be adversely impacted by the outcome of this proceeding.

## OEB FINDINGS

The OEB finds that Orillia Power's proposal is in the public interest. It is therefore necessary to vary the Decision and Rate Order such that Orillia Power shall be authorized to implement the Rate Rider for Application of Tax Change (2020) on May 1, 2020, and to postpone implementation for the balance of the Tariff of Rates and Charges to November 1, 2020. With this Vary Order, the OEB is also issuing a revised Tariff of Rates and Charges.

**THE ONTARIO ENERGY BOARD ORDERS THAT:**

The Decision and Rate Order in EB-2019-0061, issued April 16, 2020, is varied such that the Tariff of Rates and Charges attached thereto as Schedule A is replaced in its entirety with the updated Tariff of Rates and Charges set out in Schedule A, attached hereto; and, is varied such that paragraphs 1 through 5 of the Order section are replaced, in their entirety, with the following:

1. The Tariff of Rates and Charges set out in Schedule A of this Decision and Rate Order for Orillia Power Distribution Corporation is approved effective May 1, 2020 for electricity consumed or estimated to have been consumed on and after such date.
2. In light of the COVID-19 emergency, and subject to paragraphs 3 and 4, the Tariff of Rates and Charges is approved to be implemented November 1, 2020.
3. Any temporarily forgone distribution revenue associated with the postponement referred to in paragraph 2 may be tracked in Account 1509 - Impacts Arising from the COVID-19 Emergency, Sub-account Lost Revenues.
4. The portion of the Tariff of Rates and Charges relating to the Rate Rider for Application of Tax Change (2020) shall be implemented on May 1, 2020.
5. Orillia Power Distribution Corporation shall notify its customers of the rate changes no later than the delivery of the first bills reflecting the new final rates.

Separately metered dwellings within a town house complex or apartment building also qualify as residential customers. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

Class A and Class B consumers are defined in accordance with O.Reg.429/04. Further servicing details are available in the distributor's Conditions of Service.
